The bids will be opened in the presence of Bidders' representatives who choose to attend at B.S. 2081/09/10 [25th December, 2024]. on 13:00 hours at the office of Ministry of Social Development, Youth and Sports, Pokhara, Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 40,000.00, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account no. 1000100200010000, Office Code no.: 3500039014 at Rastriya Baniija Bank Limited and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
