4. Pre-bid meeting shall be held at Ministry of Social Development, Youth and Sports, Gandaki Province Pokhara-07, Kaski at 27-12-2024 11:00 hours.
5. Electronic bids must be submitted to the Ministry of Social Development, Youth and Sports, Pokhara, Nepal by hand or through e-GP system; www.bolpatra.gov.np/egp on or before 12:00 noon on B.S. 2081/10/10 [23th January, 2025]. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at B.S. 2081/10/10 [23th January, 2025]. on 13:00 hours at the office of Ministry of Social Development, Youth and Sports, Pokhara, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 1,12,000.00, which shall be valid for 30 days beyond the validity period of the bid. The bid security may either be in the form of a bid security issued by authorized Financial Institution according to format provided in Bid Document or cash deposited in Deposit Account no. 1000100200010000, Office Code no.: 3500039014 at Rastriya Banijya Bank Limited and submit the receipt of the deposited amount of cash.
7. If the last date of purchasing and/ or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
